

ADMISSION TO THE RYDER CUP

TICKET CONDITIONS

Ticket holders are asked to carry photographic proof of identity (Passport or Driving Licence) and plans are in place to rigidly check all spectator tickets at the North and South Park and Rides, and the North and South Bus Terminals. Ticket holders are also encouraged to arrive early and allow plenty of time to travel.

- All tickets are for nominated ticket holders only.
- Ticketing checks for entry to The Ryder Cup will be administered at both Park and Ride points by security staff, before spectators are then transported to and from The K Club on a fleet of coaches.
- All persons and regulation bags will be subject to search. No bags larger than 8" x 8". Please be advised that if guests choose to bring a bag smaller than 8" x 8", the bags will be subject to search which might lengthen the amount of time it takes to pass through ticket and security checkpoints.
- All tickets will be validated upon entry.
- All guests may be subject to random identification checks. For safety and security reasons, guests are advised to carry personal identification.
- Please make a note of your ticket number and carry the number with you at all times.
- NO PASS-OUTS will be issued and re-entry to the event is not permitted on any day.
- There will be no ticket sales on the gate.
- See additional terms and conditions on the back of your ticket.
- Tickets must be displayed at all times.

DAILY TICKETS

Provide access to the grounds of The K Club only on the date shown on individual tickets.

SERIES TICKETS

Provide access to the grounds of The K Club on Thursday, September 21 and Friday, September 22 OR Saturday, September 23 and Sunday, September 24 (both 2-day) and Thursday, September 21 to Sunday, September 24 (4-day).

INTERNATIONAL PAVILION TICKETS

Provide access to the grounds of The K Club from Tuesday, September 19 to Sunday, September 24 as well as access to the International Pavilion. The location of the International Pavilion may be found on the Site Map in this booklet or spectators may refer to the Locator Boards on-course.

HOSPITALITY TICKETS

Provide access to the grounds of The K Club on the ticketing date shown as well as admission to the specific hospitality area(s) indicated on the ticket. The location of hospitality areas may be found on the Site Map in this booklet or spectators may refer to the Locator Boards on-course.

As guests arrive at their hospitality facility their tickets will be checked and validated and a hospitality wristband will be issued. Wristbands and hospitality tickets must be displayed at all times and will be required to re-enter the hospitality area(s) through the day.

RAIN POLICY

If it rains on any day of the event, play will continue as long as it is deemed safe to do so. A daily ticket is only valid on the day for which it is issued. Therefore, a rain delay does not allow that day's ticket to be used on another day of play.

Should the final day's play on Sunday, September 24 have to be carried forward to Monday, only spectators holding valid tickets for SUNDAY will be guaranteed access to the course for play on Monday.

LOST TICKETS

Tickets lost on the golf course should be reported to the Finance & Accreditation Office located close to Entrance/Exit to the North Bus Terminal (see Site Map).

You will be required to produce proof of identity and details of your tickets. Please carry a note of your ticket number with you in order to facilitate identification and replacement. Upon notification to the Finance & Accreditation Office, your lost ticket will immediately become invalid.

GROUND REGULATIONS

All tickets are subject to the Ground Regulations as set out herein or as further amended by Ryder Cup Europe LLP from time to time.

1. All persons must comply with instructions and decisions given by the Officials, Stewards and Police Officers.
2. Proof of identity and age, where an age concession is claimed, may be required.
3. Right of admission is reserved at the discretion of the Management. Where admission is refused or the bearer is evicted from the venue and/or demarcated areas for any reason whatsoever, no refund shall be paid.
4. Entry to the ground is only permitted to spectators who agree to be searched on entry.
5. The selected ticket must be produced at appropriate entry points and/or on demand by any authorised official.
6. Entry into the venue and demarcated areas will not be allowed to persons bearing cameras, mobile phones, animals (guide dogs permitted), step ladders, dangerous weapons, fireworks /explosives, smoke canisters, incendiary devices, flares, sticks and poles (including flag poles), klaxons, megaphones and compressed air or gas operated horns, banners, alcoholic beverages, musical instruments, balls, frisbees and similar items, bicycles, scooters, skateboards, skates including in-line skates, non-accredited media equipment, cans and glass containers, deck chairs, gazebos, any objects or clothing containing political or commercial identification in breach of condition 7 below, any other objects or items which may be deemed in the discretion of Management to be offensive, disruptive, dangerous or likely to infringe any party's rights or any party's safety or security or any dangerous article or substance not referred to above. Management reserves the right to confiscate or replace with product of an equivalent quality and value any non alcoholic beverages or other products including branded food and non alcoholic beverage products which, in its opinion, the importation of which will or may infringe any party's rights or any party's safety or security.
7. The purchaser shall not engage in any form of "ambush marketing" (ambush marketing is an activity by a party which utilises the publicity value of an event without having any official involvement or connection with the event) and shall not breach or infringe the rights of any sponsors, suppliers, broadcasters or other parties commercially associated with the Match, nor conduct unauthorised promotions or other commercial activity
8. The consumption of intoxicating liquors is permitted only in the bars or other authorised areas or places during hours decided by the Management, and the right is reserved to close bars at any time.
9. The playing areas of the golf course shall be out of bounds at all times.
10. The purchaser shall not behave in any manner deemed by Management to be disruptive, to endanger the safety of other persons in the venue and/or demarcated areas or to unreasonably obstruct the viewing of other spectators. No person shall throw or discharge any missile or other article. Racist chanting or the use of foul or abusive language will not be tolerated.
11. The obstruction of gangways, access-ways, exits, entrances or staircases, congregating in non-designated areas or seeking entry to stands or seats for which the purchaser does not hold a valid ticket is strictly forbidden.
12. The climbing of walls, fences, stands or any other buildings in the venue is strictly forbidden.
13. Defacing or obscuring any notice or advertisement is strictly forbidden.
14. The use of cameras, mobile phones, computers and other electronic equipment for the recording, transmission or communication of match details, statistics, images etc is not permitted other than with the proper accreditation.
15. Failure to observe and abide by these regulations shall constitute a breach of contract and may result in eviction from the venue and/or demarcated areas, cancellation or confiscation of this ticket and/or legal action by Management.
